Explosive update on 9/11 10 Years Later:

Lloyd's sues Saudi Arabia for funding 9/11

A Lloyd's of London insurance portfolio is suing the Saudi government, Saudi charities and Saudi banks for financing the 9/11 terrorist attacks. On 8th September, Lloyd's Syndicate 3500 filed suit in the Federal District Court for Western Pennsylvania in Johnstown against the Kingdom of Saudi Arabia, a number of Saudi government-run charities, and two major Saudi banks, demanding at least \$215 million in compensation for insurance payments the syndicate made to victims of the 11th September, 2001 attack. The 154-page suit charged and documented that, with out the financial and logistical support of the Saudi government and government-controlled dawas (charities), the 9/11 attacks could not have occurred. The lawsuit demonstrates that powerful circles are fully aware of the veracity of the revelations contained in the new documentary by Lyndon LaRouche's LaRouche Political Action Committee, *10 Years Later*, which reveals the complicity of the Saudi Arabian government, as well as the British government, in the 9/11 attacks; the Lloyd's lawsuit does not address the British role [See *10 Years Later* at www.larouchepac.com/10yearslater].


The Lloyd's suit was premised on the argument that, while the costs of the 9/11 attack *per se* were limited, Al-Qaeda had a \$35 million-a-year budget that was largely covered by payments from the Saudi Royal Family and allied circles. The suit provided very detailed allegations about the role of the Saudi régime in sponsoring, financing and supporting Al-Qaeda over the 13-year period from 1988 through to the 11th September, 2001 attacks.

The evidence compiled for the law suit was based almost exclusively on U.S. and Saudi government documents, including publicly available evidence provided by scores of Guantánamo Bay detainees, who were picked up as

"enemy combatants" and who were affiliated with either Al-Qaeda or the Saudi charities named in the suit. Among the nominally private dawas named in the suit were: The Muslim World League, the Saudi Red Crescent Society, and a variety of Saudi charities that funded the wars in Afghanistan, Bosnia, Kosovo, and Chechnya. All of these organisations were controlled by the Saudi Ministry of Religious Affairs and by Saudi Arabia's Interior Minister, Prince Nayef bin Abdul-Aziz, who is now second in line to be King, and who chaired the government committee overseeing all of the named charities.

Despite the suit's shortcoming in making no mention of the British hand in the Saudi-sponsored terrorism, particularly the Al-Yamamah program

of Anglo-Saudi slush funds financing the Afghan mujahideen and what later emerged as Al-Qaeda, it presents a damning case against the Saudi Royal Family and some of the most prominent Saudi bankers and businessmen, all of whom were part of the "Golden Chain", a group of wealthy Saudi princes and millionaires who were on a computer document, captured in Bosnia, detailing the financing of the worldwide jihadi movements. The suit was filed in the Western District of Pennsylvania near the site where one of the four 9/11 hijacked commercial airliners crashed. Days after the suit was filed, Vice President Joe Biden and former President Bill Clinton presided over the 9/11 commemoration just miles from Johnstown.

10 Years Later—the real story of 9/11

For the truth about the 11th September, 2001 terrorist attacks, and why American statesman and physical economist Lyndon LaRouche called it an “inside job”, watch the new LaRouche Political Action Committee (LPAC) online video, *10 Years Later*. 10 Years Later details how two foreign governments—the Saudi and the British—have been implicated in the attacks, which has been covered up by both the Bush and Obama administrations.

LaRouche, an expert in international security and counterintelligence, first warned of terrorism in an international webcast on 3rd January, 2001, eight months before the attacks: “What you’re going to get with a frustrated Bush Administration, if it’s determined to prevent itself from being opposed—its will—you’re going to get crisis management, where members of the Special Warfare types, of the Secret Government, the secret police teams, and so forth, will set off provocations, which will be used to bring about dictatorial powers and emotion, in the name of crisis management,” he said. “You will have small wars set off in various parts of the world, which the Bush Administration will respond to, with crisis-management methods of provocation. That’s what you’ll get. And that’s what the problem is, and you have to face that.”

On the morning of 11th September, 2001, LaRouche was being interviewed live on the Jack Stockwell radio show in Utah, as the news of the attacks was breaking. Within minutes, before any official pronouncements, LaRouche said, “First of all, the first suspicion that’s going to be on this is Osama bin Laden”, but, LaRouche emphasised, the whole operation by its very nature had to be far more complex.

Then, when the news came through that the Pentagon too was attacked, LaRouche told Stockwell, “This means that there’s been some kind of either incompetence or a fix on the whole security operation, because you can’t get this kind of thing without a real goofup, on the security side. So somebody in charge of security was not really very effectively in charge. You can’t go around snatching planes in a coordinated fashion, like this. You can’t do it ... Somebody wants this thing to go out of control. That’s why they’re doing this. This is not an attack; this is a *provocation*. It’s a provocation with an intention behind it. To create a programmed reaction from the institutions of the United States. This is not some dumb guy with a turban some place in the world, trying to get revenge for what’s going on in the Middle East. This is something different.”

10 Years Later documents:

Twenty-four hours after the attacks, when all flights were grounded, a jet carrying the heads of British intelligence—MI6 and MI5—landed in Washington DC. The head of the CIA later commented he had no idea how the flight received clearance. Less than a week later, a flight was allowed to leave the U.S. carrying over 100 Saudis, including 24 members of the Bin Laden family.

Until the year 2000, Osama bin Laden had maintained a luxury home in Wembley, London, harboured by the

British government.

Saudi Prince Bandar bin Sultan, the one-time Saudi ambassador to both London and Washington, brokered the Al-Yamamah arms deal with BAE Systems that provided a multi-billions slush fund for financing terrorism and arms deals, the investigation of which by Britain’s Fraud Office was personally shut down by Tony Blair.

Prince Bandar and his wife, while he was ambassador to the U.S., personally financed the living arrangements and flight training in the U.S. of two of the identified 9/11 hijackers.

The Saudi-British slush fund is still active, which presents the threat of more terrorist attacks.

In October 2007, LaRouche laid out the truth of 9/11 to an international webcast:

“In early January of 2001, before the inauguration of George W. Bush as President, I warned that the general nature of the catastrophe would be, that the U.S. economy would be a failure—the policies of Bush would be a total failure: We were headed into a downslide, which in fact has happened, all throughout this period. And the thing we had to fear, from *inside the U.S. government*, was that someone would set off a form of terrorist incident within the year, which would shock the nation into submission.

“In the summer of that year, 2001, the recession was fully on. The collapse was on; the political systems were shaken by the collapse. And then, on the famous September 11, someone, with cooperation from inside the highest levels of power in the United States, unleashed an incident which is called the 9/11 incident. That job was done with the complicity of the British Empire. It was done with complicity of elements in Saudi Arabia, as all the evidence would plainly tell you. That was a terrorist act, against the United States, done with complicity of people at a very high level *inside* the United States, with a coverup organised by people inside, a high level inside the United States. “Now, certain facts are not known, and I shall not say what I know now. But I shall say, that I do know, beyond doubt, that 9/11 was an inside job. It was an inside job on behalf of what the Bush-Cheney Administration represents. And since that time, everybody who knows anything about the government, knows about our system, knows that more or less to be true. You see the behavior of members of the Congress and political institutions who are running scared! Because they know that kind of thing is on.”

A decade on, the shocking memory of 9/11 makes us reiterate our determination that this must never again be allowed to happen, but, equally, the way circles around Tony Blair and Dick Cheney twisted the attack to orchestrate the deadly invasion of Iraq on a deliberate lie, the ongoing quagmire of Afghanistan where soldiers are being ground up to effectively protect opium crops, and the fascist police-state laws which stripped away our fundamental rights, must motivate us to learn and expose the truth of 9/11.
