

LaRouche on Global Debt Crisis:

“Enact Glass-Steagall, Now!”

May 25—As the global financial crisis continued to explode out of control, a crucial vote with international ramifications took place in the U.S. Senate on 20th May on the so-called “Financial Reform Bill”. Ostensibly designed to deal with the crisis, the bill is a piece of Wall St.-endorsed garbage. The real issue was whether the Senate leadership would allow a vote on a proposed amendment to it, to restore a “Glass-Steagall” firewall against precisely the kind of Wall St./City of London speculation which has caused the present crisis. “Glass-Steagall” was enacted in 1933 to rein in Wall St., to facilitate President Roosevelt’s infrastructure-led economic recovery program, but was repealed at the demand of Wall St. and London in 1999. (See p. 2.)

Shortly before the May 20 vote, a most curious incident took place: the British Foreign Office declared that it would re-

gard the renewal of Glass-Steagall as a “hostile act” against the British Crown and the City of London. Why in the world would the passage of U.S. domestic legislation be a mortal threat to Queen Elizabeth and the City of London? Because, as American economist and statesman Lyndon LaRouche has repeatedly emphasised, restoring Glass-Steagall is the first step to writing off quadrillions of dollars of derivatives and other speculative instruments, without which there will never be a recovery of the actual physical economy. But, acting as toadies for the British, President Obama and the Senate leadership rammed through the “Financial Reform Bill” without the Glass-Steagall amendment, despite its overwhelming bipartisan support.

The global financial crisis


The eruption of the eurozone debt crisis in early May

is merely the latest in a series of ever-worsening global financial crises dating back to August 1971, when U.S. President Nixon, also acting as a flunky for Wall St. and the City of London, took the dollar off gold. That ended the fixed-exchange rate Bretton Woods system, and opened the door for unbridled speculation in

currencies and other financial instruments. As investment drained out of the real physical economy of agriculture, industry, and infrastructure, into speculation, financial shocks came one after another in rapid succession. These included: the October 1987 U.S. stock market collapse, the greatest ever; the near col-

lapse of the global system in 1997-98 with the “Asia”, “Russian bond”, and “LTCM hedge fund” crises; the “mortgage crisis” which erupted in August 2007, still ongoing; the near global crashes in 2008 and 2009, averted only when the U.S. and European governments bailed out the banks with an estimated \$30-40 trillion; and the present “Greek” and “euro” crises.

Governments “solved” each crisis by pouring taxpayers’ money in to bail out the private banks, but each bailout only created a larger, even more explosive bubble for the next round. Now, physical economist LaRouche—whose track record of economic forecasting since 1956 is unmatched—warned on 20th May that, “The world as a whole stands on the edge of a sudden, overnight collapse.... We could wake up one morning, and find that we have no financial system at all—an instant plunge into a New Dark Age.” We must immediately shut down the quadrillion-dollar derivatives trade, the most volatile aspect of the bubble, LaRouche said. And, regardless of the 20th May vote, we must ram through Glass-Steagall in the U.S. as a model for the world.

A new, revolutionary phase of history

Were we dependent upon the existent political class of fools

and traitors such as Obama, Kevin Rudd and their ilk, the world would never survive. Fortunately, however, an entirely new factor has emerged in U.S. and global politics over the past several months—a mass upsurge of populations of entire countries in response to the crisis. Beginning in the U.S. in August, for instance, hundreds of thousands and even millions of U.S. citizens took to the streets in opposition to Obama’s genocidal, Adolf Hitler-modeled “health reform bill” (which Kevin Rudd is now emulating). Over the past several months, a whole series of U.S. Senators and Congressmen from both parties, many of whom have held office for decades, have suffered shocking electoral defeats. Most stunning, perhaps, was the victory of LaRouche Youth Movement leader Kesha Rogers in the 2nd March Democratic Party Congressional primary election in the 22nd district in Texas. Campaigning relentlessly as a LaRouche Democrat for the impeachment of Obama (the head of her own party!), Kesha won 52% of the vote against two opponents, trouncing the Democratic party-endorsed candidate.

With LaRouche’s strategic leadership, this revolutionary upsurge offers enormous hope. So isn’t it time you joined the CEC and LaRouche, to help fight our way out of this mess?

LaRouche to Australia: Join in the Recovery

Lyndon LaRouche used his keynote address to the 1st - 2nd May CEC National Activists Conference to highlight Australia’s important role in the necessary global reorganisation of “what is now a totally, hopelessly bankrupt world economy in general.” His call for a Four Powers agreement between the U.S., Russia, China and India to break the back of the British monetarist empire, is central to a successful reorganisation, he said, but prominent among the other nations with an important contribution to make, is Australia.

Noting that the centre of gravity of the world economy is shifting to the Pacific, LaRouche emphasised that “in the Pacific Rim area, the western Pacific Rim” where Australia is located, “the situation here is that Australia has certain, among other things, certain raw

materials, such as thorium, and uranium”, which are vital to the coming, nuclear-powered global economic recovery. In Eurasia, he explained, only Russia has a similar surplus of resources, whereas the huge population nations of China, and India have a shortage, as do the nations of Japan and South Korea which have an important technological contribution to make to a recovery. “And that’s where Australia comes in, as one of the nations, the island nation, so to speak, which has a good deal of this sort of thing, which really has a great market for a condition of growth, in Eurasia”, with tremendous prospects for Australia’s own agro-industrial growth.

Once the world economy is put into bankruptcy reorganisation, to sort out the financial system using the Glass-Steagall standard, then a recovery

can be launched around great infrastructure projects, particularly in power, transport, and water. “You have an island nation, which is sitting there,” he said, “with a very poor degree of development per square kilometre of territory, but with the potential for a very rapid development of both the market, and the infrastructure development, within the continent.”

Stressing the need to create cultural optimism, LaRouche urged Australia to develop a space program, for which it has a unique capability. Finally, he concluded, “If we make this kind of reform, civilisation will live. If we don’t make this kind of reform, civilisation will die.” Australians know what they can do, know what they have done in the past with “great infrastructure projects such

as the Snowy”, and what they could have done, but didn’t under British imperial policies: “So why not do it? Why not have a great time? You’re not going to get that rich all of a sudden, but you’re going to have a good life, with the sense that your children’s generation have something meaningful waiting for them down, say two generations down the line, and a constant improvement in the conditions of life, in the meantime.” LaRouche has closely followed developments in Australia over the years, and in the mid-1990s helped the CEC develop its ready-to-enact legislation for a new Commonwealth National Bank. CEC Hammers Genocide Policies

Following Lyndon LaRouche’s keynote address to the CEC’s 1st - 2nd May National Conference, CEC leader Craig Isherwood used his own opening remarks to launch the party’s federal election campaign. The intent of the CEC’s campaigns, he declared, is to destroy the British Crown’s plot to depopulate Australia, along with the rest of the world, under the euphemisms of “population control” or “population stabilisation”—polite terms for actual geno-

cide. Via his World Wildlife Fund and other “conservation” fronts, Prince Philip has long campaigned to reduce the world’s population down to two billion or less, as in his expressed desire to be “reincarnated as a deadly virus in order to help solve the overpopulation problem”, or in his recent public wish for Britain’s own population to plunge from its present 60 million down to its 16th Century level of only three million.

Craig announced his own


flagship candidacy for the suburban Melbourne seat of Wills against the federal parliament’s leading population-control genocide-promoter, the ALP’s Kelvin Thomson, and also unveiled four flanking campaigns being run by the CEC’s state secretaries against key targets: WA State Secretary Jean Robinson in O’Connor; National Chairman and NSW State Secretary Ann Lawler in Charlton; Queensland State Secretary Jan Pukallus in PM Kevin Rudd’s seat of Griffith; and Tasmanian

State Secretary Adrian Watts in Bass. (See p. 4.)

Following is the abbreviated text of Craig’s speech, *Destroy Empiricism and Genocide: Let’s Go to Mars*.

I would like to talk about two primary issues this morning, issues which will define all the CEC’s work in Australia for the indefinite future. I will just barely open the file, so to speak, on each of these two matters, which we will

elaborate in the coming days, weeks, and months.

These two issues are, first: the commitment by the world financial oligarchy, led by Prince Philip and the Queen, to bring the world’s population down from its existing 6.8 billion or so, to two billion, or even much less. That is, they intend to commit by far the biggest genocide in the history of the human race, making Hitler look like a Sunday School teacher by comparison. And genocide is also the policy of the present Australian government. It is the official, announced policy of Kevin Rudd, and it was the policy of John Howard before him, and of Hawke and Keating earlier.

Already back in 1991 Hawke set up a thing called the “National Population Council”, which made two key recommendations: that the Department of Immigration become the “Department of Population”, and that the then Bureau of Immigration Research become the “Bureau of Population Research”. And there have been numerous other commissions established by various Australian governments on this same topic ever since, amidst incessant propaganda about “population control”, or “population stabilisation”, terms which, in the real world, mean killing millions of Australians.

Shocking as it may be, it is precisely that intention—and no other—which shapes every single other policy which is wrecking this country, whether it be

shutting down the Murray-Darling Basin and virtually all independent family farms, shutting down all our industry except for Her Majesty’s mining cartels, or the so-called health “reforms” which Kevin Rudd is trying to ram through here—which are precisely as genocidal in their conscious intent as what that other British agent, Barack Obama, is doing in the United States. If we don’t take on this issue, of so-called “population control”, we can’t solve anything else.

After all, you all know something about the method of physical economy of our dear friend Lyndon LaRouche, about the way the economy must function, if it is to function at all.

What is the fundamental metric of his science of physical economy?

Yes! *A rising rate of increase of potential relative population density!* So, both on our side, so to speak, the side of human beings in general, the issue is population—the need for an ever greater human population, and population is also the issue for the enemy—getting rid of it. It’s all Prince Philip ever thinks about; presuming, that is, that he does think, which is rather dubious.

Okay, so that’s the first issue—population. The second, is something about which I have the sneaking suspicion that virtually nobody in this room has paid any serious attention to so far; I know I myself hadn’t until recently, notwithstanding Lyn’s [La-

Rouche’s] constant emphasis on it of late, and that is the subject of cosmic radiation... [For a summary of Craig’s remarks on the profound subject of cosmic radiation—which permeates the entire universe—please see the conclusion of his speech on page 4.]

Now let me ask you: which is the more powerful force in the Universe: Prince Philip—or cosmic radiation?

And I think that puts our present political task here in Australia into perspective. Because virtually all Australians are convinced, including almost everyone in this room, that there is a “They” out there, an all-powerful “They”, which runs everything; which, among other things, has been systematically wrecking this country since at least the time the Queen dumped Gough Whitlam in 1975; which runs the economy, whatever is left of it; which runs the mass media; which runs the whole political system, inside Parliament and outside it. But the reality is, looked at from the standpoint of the beautiful, vast spaces of stellar space filled with cosmic radiation, this “They” that we all fear so much, this seemingly all-powerful financial oligarchy, are a bunch of pathetic clowns. I mean if they are so great, so wise, so all-powerful, how come their whole system is collapsing? So, with Lyn’s leadership, we have to clear this rubbish out of the way, at the top, on a world scale, and we have to do our bit here in Australia, because of course it is the precise same enemy. We have to take them out, take out the garbage.

Therefore, I want to officially announce today, for the first time, that I will be running for Federal Parliament against a guy who is a virtual poster boy for the genocide lobby. A guy whose single major campaign issue, which he trumpets from the roof tops, is “population reduction”—genocide. And that is Kelvin Thomson, from right here in our own back yard, in the Wills electorate.

So, I promise you—we are going to have a lot of fun! And I have a sneaking suspicion that our youth might want to jump into the fray here in Wills against Kelvin Thomson. Watch for the fireworks!

Now look: this genocide commitment is not exactly a secret, right? I mean, it has become so bad that some idiots or British agents out there have even formed a political party for this coming election named the “Stop Population Growth Now” party, and of course the media is giving them plenty of attention. And, as you probably noticed, Kevin Rudd earlier this month named frontbencher Tony Burke to head the Federal Government’s first-ever “Population Ministry”, in order to so-call “manage” Australia’s popu-

lation growth, i.e. to help wipe it out. And this in a country with the third lowest population density per square kilometer in the entire world! Above only Mongolia and Namibia.

And all this overt propaganda and planning for genocide takes place in a world which otherwise has visibly gone mad. Here we are in the middle of the greatest financial catastrophe in human history, and also on the edge of an obviously insane war against Iran, which would trigger a holocaust for a century or more in the Middle East and destroy what is left of the world’s economy by a massive new oil shortage, real or contrived. Here in Australia our farms, our industries, our jobs, and even our own houses, are disappearing at a shocking rate. You have seen the foreclosure figures we put out during our campaign for the *Homeowners and Bank Protection Bill*, and they have only grown worse since. Literally millions of Australians have either already lost, or soon will lose their homes.

[Craig pointed out that the public’s inaction in the face of such existential crises is clinically insane. It is a result of the British-promulgated mental disease of empiricism—the notion that what our mere senses perceive is truth. What the British oligarchy fears the most, he emphasised, are the actual creative powers of the human mind, when those powers are actually developed instead of systematically suppressed as they are at present, by the educational system, popular culture, etc. The most notable symptom of this disease of empiricism, is the belief that “the world has too many people”. Empiricism leads to only that conclusion, and it has become so severe that a head of state can repeatedly call for four and a half billion human beings to be murdered, and not be scorned or even tarred and feathered.]

Population control is genocide

But what I will sketch for you now, at least briefly, is the history of how the oligarchy in the modern era, meaning the last five centuries or so, and over the last 100 years or so in particular, came to adopt this policy of mass genocide as their central strategic commitment. And, as you will see, a central role in this whole proj-

ect from no later than the 1890s, has been played by the Fabian Society. The same Fabian Society of which our own local genocide-promoter Kelvin Thomson was the past president for Australia. Proud member and past President of the Fabian Society of Australia—that’s our boy Kelvin, the Federal Member for Wills.

At Christmas time last year Kelvin delivered a “Wills Report” into the letterboxes of everyone in Wills. In it he said:

“On 11 November at the Royal Park Protection Society Annual General Meeting I released my plan to stabilise Australia’s Population.

“**Population projections for Australia and the world are too high and unsustainable. I believe global warming, water shortages, food crisis, overcrowded cities, transport congestion, species extinction, waste, housing affordability, rising cost of living, war and terrorism are all either caused by or exacerbated by rising population....**

“**I am of the strong belief that Australia must be moving to stabilise its population in order to secure its social, environmental and economic future. Rather than sleepwalk into an environmental and social disaster, I have put forward a 14 Point Population Reform Paper that sets out how we can stabilise our population at 26 million by 2050.”**

Now Kelvin doesn’t recommend, at least not that I have seen in print, that all of you should run out and buy axes with which to murder your neighbours. But he does conclude his rant by calling on everyone to take a more socially acceptable path to the same end: to join Sustainable Population Australia (SPA). And who is the SPA? (Not to be confused with the SPCA, which is the far more humane, even human, by comparison, with the Society for the Prevention of Cruelty to Animals.)

The SPA has overlapping leadership with the Australian Conservation Foundation, which of course was founded by Prince Philip himself, and he even personally chaired it from 1971-76. The guy who replaced Philip as head of the ACF was our old friend, Mr. Aboriginal Land Rights

The Genocide File: The Campaign to Depopulate Australia

Here is a summary of the evidence Craig presented on the genocide campaign against Australians:


* PM Kevin Rudd in April announced the creation of a brand new “Population Ministry” to be part of the Federal Cabinet. Craig’s opponent Kelvin Thomson had been tipped to head this, but is such an obvious raving ideologue, that his very fanaticism was probably deemed harmful to the cause.

* Kelvin Thomson together with Sustainable Population Australia—whose leadership overlaps that of the Australian Conservation Foundation—are presently sponsoring a series of nationwide “Speak-Outs” on “overpopulation” in Australia and its dire consequences, which feature a fair number of nationally known figures, including state and federal MPs. Thomson has previously called upon everyone to join Sustainable Population Australia.

* In March 2010, the ACF, which Prince Philip not only personally founded as the Australian wing of his WWF, but which he also personally chaired from 1971-76, came out of the closet and called for population growth to be declared an “environmental threat” under federal law, just like cane toads, feral cats, and other destructive vermin.

* A new national party has just been formed to contest the year-end elections, the “Stop Population Growth Now” party.

* Thomson recently letter-boxed his entire Wills electorate with a flyer containing his genocidal 14-point “Population Reform Paper”, which sets out “how we can stabilise our population at 26 million by 2050”.



What is “Glass-Steagall”?


The 1933 *Glass-Steagall Act* was a leash on Wall Street for 66 years. It established a firewall to protect the financial functions of banking that were necessary to the daily lives of the American people, from the speculators on Wall Street. Specifically, under Glass-Steagall, commercial banks which held deposits protected by the Federal Deposit Insurance Corporation (FDIC)—the savings accounts, chequing accounts, and business trading accounts—were forbidden from owning, or being owned by, Wall Street investment banks. It didn’t stop speculation, but it severely curtailed it, because it denied Wall Street investment banks any access to the enormous deposit base of the American people. It was when Glass-Steagall was

repealed in 1999, that Wall Street finally got access to the commercial banks and their deposits, and all forms of speculation expanded exponentially.

Cantwell-McCain

The Cantwell-McCain amendment introduced into the U.S. Senate on 6th May, 2010 as an amendment to the “Financial Reform Bill” (See lead article, p. 1.) would prohibit commercial banks from affiliating in any manner with investment banks and vice versa; prevent officers, directors and employees of a commercial bank from working in investment banks and vice-versa; and prohibit commercial banks from engaging in all insurance activities. Co-sponsor Sen. Maria Cantwell explained, “Behemoth

banks are putting their money into risky, get-rich-quick Wall Street schemes instead of investing in Main Street. So much U.S. taxpayer-backed money is going into speculation in dark markets that it has diverted lending capital from our community banks and small businesses that depend on loans to expand and create jobs. This is stifling America and it is why there is bipartisan support for restoring the important safeguards that protected America for decades after the great Depression. It’s time to go back to separating commercial banking from Wall Street investment banking.” Fellow co-sponsor Sen. John McCain chimed in, “It is time to put a stop to the taxpayer-financed excesses of Wall Street.”

Nugget Coombs—a self-proclaimed member of the “international freemasonry of central bankers”—who already in 1977 called for population growth to be “halted, reduced and stabilised at an ecologically safe level.” And the present head of the ACF, Professor Ian Lowe, is one of the big shots on the SPA, continuing on from Coombs’ longtime lover and co-conspirator, anthropologist and fellow Aboriginal Land Rights creator Judith Wright McKinney, who helped found the SPA in 1988, and who died in 2000. The ACF not long ago really came out of the closet to call for population control, which they themselves said that they had carefully avoided doing up until now.

Their poster boy, the kook so-called “scientist” Tim Flannery, a few years ago openly called for the Australian population to plunge from 21 million to only six million or so. He got some flack on that, so his public statements of late have been a bit more guarded. But, pretty much in line with his original call, the whole project has moved into very high gear here in this country, as it has worldwide....

But now let’s go back and look at the history of this thing, of this commitment to mass genocide. I will only have time to give you just some highlights of that, but the overall point will be clear, and we will be issuing the whole story in printed, and probably video form also before too long.

Destroy nation-states

You have all seen this graph [See Graph 1, p. 2.] of the explosion of the world’s population following the 1437-39 Council of Florence, and the birth of nation states and physical science proceeding out of that Council, particularly through the work of its foremost genius and organiser, Cardinal Nicholas of Cusa. And the commitment of the Venetian and now the Anglo-Dutch oligarchy, is to wipe out those institutions: to wipe out nation states—and that is pretty obvious, right? And to wipe out science

and technology which is what drives these nation states, which in the final analysis allows them to function, to actually have sovereignty....

But they had one big problem which developed on the way to their plans of eternal world imperial rule, and that was the establishment of the United States of America, as the U.S.A. was consolidated in the 1776-1781 American Revolution, in which a mere three million colonists almost all on the eastern coast of America, defeated the greatest empire the world had ever seen.

[Craig recounted the history of Britain’s counter-attack against the American republic, including the “War of 1812”, when they burned the U.S. Capitol building in Washington, D.C. and their subsequent build-up of the slave-based Southern Confederacy, whose purpose was to foment the Civil War and split the United States. But Abraham Lincoln defeated the British plot, and in so doing sparked a flowering of agro-industrial development, both in America and worldwide. Many nations adopted the “American System”, as it was called, of tariff protection, national banking, and great infrastructure projects, in particular great railroad projects such as America’s Transcontinental Railroad, the Trans-Siberian Railway which united Russia’s vast territory, and Germany’s internal railway building and planned Berlin-to-Baghdad Railway. Along with such economic development came rapid population growth, which terrified the British, while the great rail projects threatened to overthrow Britain’s worldwide maritime empire, which was based on free-trade looting and the mighty British navy. As part of this worldwide upsurge of optimism, the Australian Labor Party was founded on pro-American principles, even taking the American spelling of “Labor”. King O’Malley brought the American System to Australia, established our Commonwealth national bank in 1911, and personally organised the construction of the Trans-Australian Railway as Home Minister in the Fisher Labor government of 1910-1913.]

Fabian genocidalist H.G. Wells

So with that optimistic, courageous social process under way in Australia in those years in mind, let’s return to Britain in the 1890s, the years when H.G. Wells, Bertrand Russell, Sidney and Beatrice Webb and George Bernard Shaw and their associates were founding the British Fabian Society, the mother of all other Fabian societies worldwide, and, really, even of most so-called “Labor Parties”, certainly all modern Labor Parties, including the ALP in its present, degenerate form.

As the names of Russell, Wells, Shaw etc. indicate, we are not dealing with some kind of splinter group here. In fact, when the British Labor Party was founded in 1893, it was a merger of two institutions: the Fabian Society, and the trade union movement. And the brains of the outfit, in terms of developing policy, invariably came from the Fabians, who were the intellectuals, and who were backed by the major financiers of the City of London. Typical was the founding of the Fabian educational institution, the London School of Economics, one of the premier training grounds for “economics” in the world today, and for the last century. Most of the money came from Edward VII’s closest friend, the powerful financier Sir

Ernest Cassel, whose granddaughter Edwina would marry Prince Philip’s uncle, Lord Louis Mountbatten. So this is a very curious kind of “working-class politics” we are dealing with here, a very curious form of “socialism”. In fact, the Fabian Society was and is just the “working man’s arm” of the British Crown. Sidney and Beatrice Webb, the two hacks who did all the day-to-day grunt work in running the Society, at the direction of such as Wells and Russell, lived in Russell’s own house. They rented an apartment from him, the man whom Lyn justly calls “the most evil man of the 20th Century.”

In 1902 the Fabian leader Wells wrote a book called *Anticipations of the Reaction of Mechanical and Scientific Progress upon Human Life and Thought*. Near the end of his life he proclaimed that that book had encapsulated everything he had done for the rest of his life. In its first chapter, “Locomotion in the Twentieth Century,” Wells argued that the application of new physical principles in society, as seen specifically in the spread of railways across the globe, had “fundamentally revolutionised” the social relations which had characterised mankind for millennia, in which a small oligarchy ruled the great masses of people. This order must be reestablished, Wells preached, and the only way to do it, was through mass murder. Huge masses of what he called the “People of the Abyss”, what we would call the lower 80%, must simply be killed.

Railways, which really began to take off in the 1820s, had changed “the intellectual life of the world”, Wells wrote in *Anticipations*. And, he continued, the British Empire had responded to that railway-centred change—whose prehistory lay in the American Revolution—with its own intellectual revolution: Malthus and Darwin. Throughout the 19th Century, that duo had all but destroyed Christianity worldwide, Wells exulted, and their work must define mankind’s social organisation for millennia to come. The work of Malthus and Darwin were the premises—the “ethical reconstruction”, he called it—upon which what he called the “New Republic” was now being constructed, as the germ of the emerging new “World State”. Malthus and Darwin were the intellectual authors, in effect, of the Fabian Society, which Wells and his mates founded in order to brainwash the rising working class in Britain and elsewhere, to deploy them into operations designed to destroy the modern nation state.

Speaking as the publicist for the elite running the British Empire, Wells called for an “ethical and intellectual reconstruction” of the mental life of the world, around the ideas of Malthus and Darwin:

“Now, so far as the intellectual life of the world goes, this present time is essentially the opening phase of a period of ethical reconstruction, a reconstruction of which the New Republic will possess the matured result. Throughout the nineteenth century there has been such a shattering and recasting of fundamental ideas, of the preliminaries to ethical propositions, as the world has never seen before. This breaking down and routing out of almost all the cardinal assumptions on which the minds of the Eighteenth Century dwelt securely....”

Now of course when Wells talks about the “Eighteenth Century”, what he is really talking about is the work

of the great scientific genius Gottfried von Leibniz and his followers, which resulted in the establishment of the United States, and the optimism and belief in progress which the American Revolution unleashed worldwide in the last quarter of the 18th Century. Wells continued:

“The first chapter in the history of this intellectual development, its definite and formal opening, coincides with the opening of the nineteenth century and the publication of Malthus’s *Essay on Population*. Malthus is one of those cardinal figures in intellectual history who state definitely for all time, things apparent enough after their formulation, but never effectively conceded before. ... Probably no more shattering book than the *Essay on Population* has ever been, or ever will be, written. ... it made as clear as daylight that all forms of social reconstruction, all dreams of earthly golden ages must be either futile or insincere or both, until the problems of human increase were manfully faced.”

And, Wells emphasised, Malthus begat Darwin (and also Alfred Russel Wallace, the ostensible “co-discoverer of evolution” with Darwin). In fact, in a famous passage, Darwin said it was reading Malthus which immediately inspired his discovery of “natural selection”, the “war of each against all, survival of the fittest” concept. Malthus’s work, wrote Wells, **“awakened almost simultaneously in the minds of Darwin and Wallace, that train of thought that found expression and demonstration at last in the theory of natural selection. As that theory has been more and more thoroughly assimilated and understood by the general mind, it has destroyed, quietly but entirely, the belief in human equality... whole masses of human population are, as a whole, inferior in their claim upon the future, to other masses....”**

Wells crowed that Darwin’s work proved that mankind was not created *imago viva Dei* [in the image of God], but has always been part of nature. Therefore, he exulted, “the whole theory and meaning of the Pauline system is vain.” And by “Pauline system” he of course meant Christianity.

But since this whole intellectual scam rests upon the seminal figure of Malthus, where did he get his ideas from? Again, it all goes back to the threat to the British Empire posed by this bold new land of America, even well before the American Revolution.

Malthus the plagiarist
In 1751 Benjamin Franklin wrote a short work entitled, *Observations Concerning the Increase of Mankind*. We will reprint parts of this remarkable work before long, but in there he outlined an absolutely rigorous notion of *potential population density*. That it is the increase of science and technology which opens up an unlimited increase in population density. Now realise that Franklin was known in the 18th Century as the “modern Prometheus”, for his groundbreaking theoretical and practical work in electricity. He had literally brought the fire of the heavens down to mankind, to deploy as he wished. Franklin himself wrote about the implications of his experiments on electricity, that “There are no Bounds (but what Experience and Labor give) to the Force Man may raise and use in the Electric Way.” Indeed, along with railways, the other thing which caused the explosion of industry and population growth in the late 19th Century, was the electrification of the United States and much of Europe.

But in this 1751 work, Franklin forecast that the population of the United States would double every 25 years, and would soon outstrip that of Mother Britain herself. He was still then a British citizen, so in his typically ironic style, Franklin wrote that this great addition to English colonists (i.e. the Americans) would greatly increase the majesty and wealth of the British Empire. Of course, it was a deadly threat to the British, and to the Venetians standing in the shadows behind the British. And so, as you might expect ... a Venetian priest named Giammaria Ortes wrote a whole series of diatribes against Franklin and the rapidly growing American colonies.

Ortes wrote that the means of subsistence for a population (i.e. food) rises arithmetically, while population rises geometrically. Arithmetically, of course, means you keep adding the same unit to get a series such as 1, 2, 3, 4, 5, 6 etc., while geometrically is a doubling of each number in the series, such as 1, 2, 4, 8, 16, 32 etc. As you see, two graphs constructed of those series would diverge wildly, very quickly. But this is pure statistical kookery! It is just a sheer assertion that this is the reality, without even the slightest shred of proof presented. In fact the whole history of the world, both before then and since, has proven precisely the opposite. But these two numerical series probably sound familiar to you: today they are known as “Malthusianism”. Not long after the American Revolution, and just a year


Australia Looted by London’s “Carry Trade”

Like Brazil, Australia is the target of a “carry trade”, which is when very low interest money is borrowed from one country, and “carried” to be lent into another country with significantly higher interest rates, making enormous profits out of pure speculation. The enormous Brazil carry trade is dominated by the Lord Jacob Rothschild-led Inter-Alpha Group of Banks, especially Spain’s giant Banco Santander. This gang has extracted enormous profits by borrowing emergency bailout funds from the European Central Bank at 1% interest, and lending into Brazil at up to 16-20%; the combination of high interest rates and currency fluctuations generated an average return over the last 18 months of 24%, but sometimes as high as 37%!

Australian interest rates are not quite as high as Brazil’s, but are sufficiently high to attract a significant carry trade. Of the total \$1.23 trillion foreign debt owed by Australia, over \$800 billion is owed by Australia’s banks, and over \$440 billion of that is on 90-day terms. Most of this short-term debt is from the carry trade. It cannot be repaid, so it is constantly rolled over with new borrowing from the carry trade.

The catch is, interest rates must remain high, and climb higher, to keep attracting all of this cheap money. Brazil and Australia share similar economic trends, due to their reliance on the carry trade: the property markets of both nations are skyrocketing, as carry trade funds pour into property speculation seeking the highest return—Rio de Janeiro suffered a 50% spike in property prices in the past 12 months; but interest rates are also climbing—Brazil’s last rate hike was 0.75%, and its next is predicted to be a full 1%.

The carry trade is a monetarist scam. It generates money for the parasites running it, but only by feeding off the blood of the people who have to service the high interest rates. It can only ever be short term: when the interest rates get so high that the people can no longer meet the usury, the trade collapses.



Following U.S. President Lincoln’s victory over the British-sponsored, slave-holding Confederacy in the U.S. Civil War (1861-65), America’s industrial might and population skyrocketed. This terrified the British Empire.

or so after Ortes had died, Lord Shelburne, the boss of the British East India Company told Parson Malthus—an employee of the East India Company!—to just copy Ortes' work, and issue it in his own name. Which he did. Informed people at the time knew it was plagiarism, and an Ortes admirer by the name of Karl Marx made that charge publicly.

"Kill 'em off"

So presuming this statistical hocus-pocus proving that population outstrips the means of subsistence to be true, what did the very Reverend Malthus propose to do about it? In a subsequent edition of his *Essay on Population*, Malthus let it all hang out:

"All the children born beyond what would be required to keep up the population to this level, must necessarily perish, unless room be made for them by the deaths of grown persons. ... therefore, we should facilitate, instead of foolishly and vainly endeavouring to impede, the operations of nature in producing this mortality...."

"Instead of recommending cleanliness to the poor, we should encourage contrary habits. In our towns we should

make the streets narrower, crowd more people into the houses, and court the return of the plague. In the country, we should build our villages near stagnant pools, and particularly encourage settlements in all marshy and unwholesome situations. But above all, we should reprobate [condemned.] specific remedies for ravaging diseases; and those benevolent, but much mistaken men, who have thought they were doing a service to mankind by projecting schemes for the total extirpation of particular disorders."

In his book *Anticipations*, Malthus disciple Wells ranted against God and the immortality of the soul; concepts which he said would be wiped out in the coming "New Republic" and "World State". As for policy recommendations following on from Malthus and Darwin, Wells wrote in that book's concluding chapter, "The Faith, Morals, and Public Policy of the New Republic", that the "World State", which will reestablish the old order of ruling elite/mass of ruled, will only emerge via *mass murder*:

"While the New Republic is gathering itself together and becoming aware of itself, that other great element, which I

have called the People of the Abyss, will also have followed out its destiny. For many decades that development [i.e. population growth—ed.] will be largely or entirely out of all human control. To the multiplying rejected of the white and yellow civilisations there will have been added a vast proportion of the black and brown races, and collectively those masses will propound the general question, 'What will you do with us, we hundreds of millions, who cannot keep pace with you?' ..."

"And how will the New Republic treat the inferior races? How will it deal with the black? How will it deal with the yellow man? How will it tackle that alleged termite in the civilised woodwork, the Jew? ... And for the rest, those swarms of black, and brown, and dirty-white, and yellow people, who do not come into the new needs of efficiency? Well, the world is a world, not a charitable institution, and I take it they will have to go ... it is their portion to die out and disappear. ..."

"The men of the New Republic will not be squeamish, either, in facing or inflicting death, because they will have a fuller sense of the possibilities of life than we pos-

sess. They will have an ideal that will make killing worth the while; like Abraham, they will have the faith to kill, and they will have no superstitions about death."

I could cite you tons of other quotes from Russell, from the Webbs, from George Bernard Shaw, and from most of H.G. Wells' other associates, all calling for mass murder. The "great" playwright Shaw even called for the construction of "death chambers" to take care of the problem. But I think the point is clear. And with an eye towards this would-be mass genocide-promoter Kelvin Thomson, be aware that all the top Fabians, these oh-so-sincere-socialists, were also overt, raving imperialists. In fact, the Fabian Society even issued an official pamphlet in 1900 entitled "Fabianism and the Empire", written by George Bernard Shaw, to explain why all good Fabians were "necessarily imperialists".

The whole doctrine of economics, as it is taught virtually everywhere in the world outside LaRouche's movement, all descends directly from Malthus. The Brits, like John Maynard Keynes—the big authority cited today to justify the mega-trillion dollar bailouts of Wall St. and the City of London—even brag about that. And Keynes, whose monetarist ideas took over following President Roosevelt's untimely death in 1945, was a faithful disciple of Malthus and therefore a Director of the British Eugenics Society from 1937 - 44.

A rising rate of potential relative population density is the essential metric of a healthy economy, as LaRouche has stressed. But it is also urgently necessary

to any growing economy. Because new breakthroughs in science and technology necessitate a growing division of labour in an increasingly complex economy, i.e. a growing population. You just have to have more people, even a lot more of them, for the thing to work! And, if Prince Philip, or anyone else, were truly worried about run-away population growth, then what would they obviously do? They would be championing a space program! There are zillions upon zillions of worlds out there for human beings to colonise.

Cosmic radiation

[Part II of Craig Isherwood's keynote address contrasted the genocidal agenda of depopulation with an optimistic picture of humanity's true destiny—to explore and colonise the universe. And to discover and master the technologies that will transport people through space to distant planets and galaxies will require fundamental breakthroughs in our understanding of the universe as a whole.
